

Terms and Conditions

The Survey 2018 Competition

1. Information on how to participate in the Survey and this competition forms part of these terms and conditions. Participation in this Competition is deemed acceptance of these terms and conditions.
2. The Competition is open to members of Anytime Fitness Clubs in Australia who are on the Anytime Fitness mailing list ("Eligible Members", "you" or "your"). Owners, employees, agents and contractors of the Promoter or of Anytime Fitness Clubs and their immediate family members are not permitted to enter.
3. Eligible Members will be issued with a Survey (or electronic access to the Survey) on or about 2nd March 2018.
4. To enter, you must:
 - a. complete all parts of the Survey including answering the competition question "how will the Microsoft Surface Pro make your life easier?" in 25 words or less;
 - b. record your full name, Anytime Fitness club & telephone number on the Survey (provision of email address is optional but is required if you wish to be notified by email in the event you win the Competition);
 - c. submit the completed Survey in accordance with the instructions on the Survey by 31st March 2018.
5. The best entry as determined by a judging panel of the Promoter will win the Prize. The total prize pool is \$1,698.95.
6. Judging will take place on 2nd April 2018 at the Promoter's offices.
7. The winners of the competition will be notified on or before the 6th April 2018 by either phone or email.
8. For the purpose of these terms and conditions:
 - a. "Promoter" means Anytime Australia Pty Ltd (ABN 11 131 035 491), Level 2, 71 Longueville Road, Lane Cove NSW 2066
 - b. "Prize" means one (1) Microsoft Surface Pro i5 128gb (RRP \$1,499) & one (1) type cover (RRP \$199.95).
 - c. 'Survey' means the survey titled "The Survey" which has been distributed via the Anytime Fitness member newsletter and is available online.
9. Only one entry is permitted per person during the Competition Period.
10. The Promoter's decision is final and no correspondence will be entered into.
11. Entrants acknowledge that the Prize is being provided by a third party.
12. The winners will be notified via phone/email using the details provided on the survey. The Promoter will arrange for delivery within Australia of the Prize to the winners.

13. Where the Promoter has taken all reasonable steps to notify a winner of their prize without success or response from the winner, the prize will be held for three (3) days and if unclaimed will be retracted. The Promoter will then award the prize to the next most deserving entrant.

15. If a prize is unavailable despite the Promoter's reasonable efforts to procure it, the Promoter reserves the right to substitute a different prize item of equal or greater value subject to relevant state and territory regulations.
